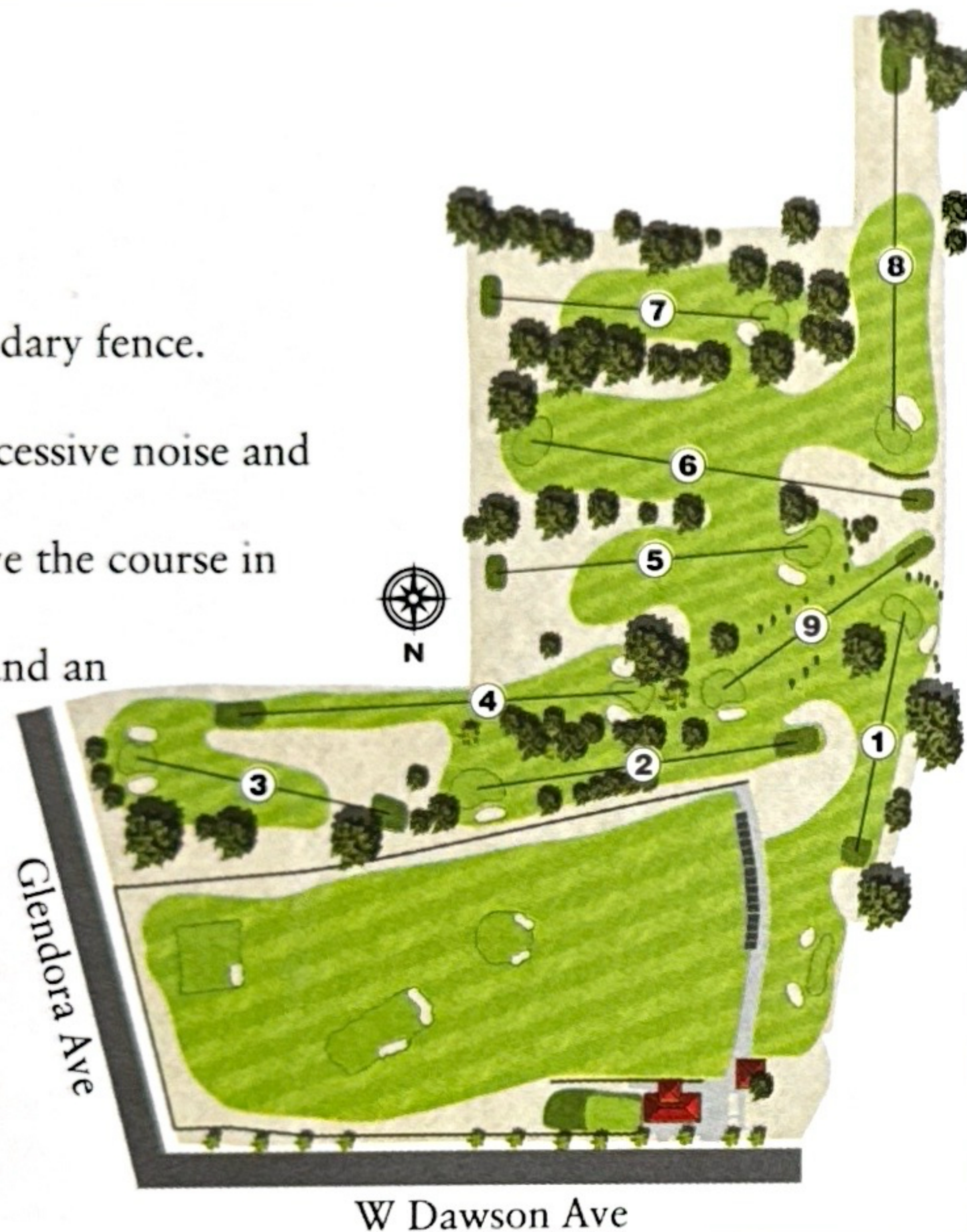


Course Rules

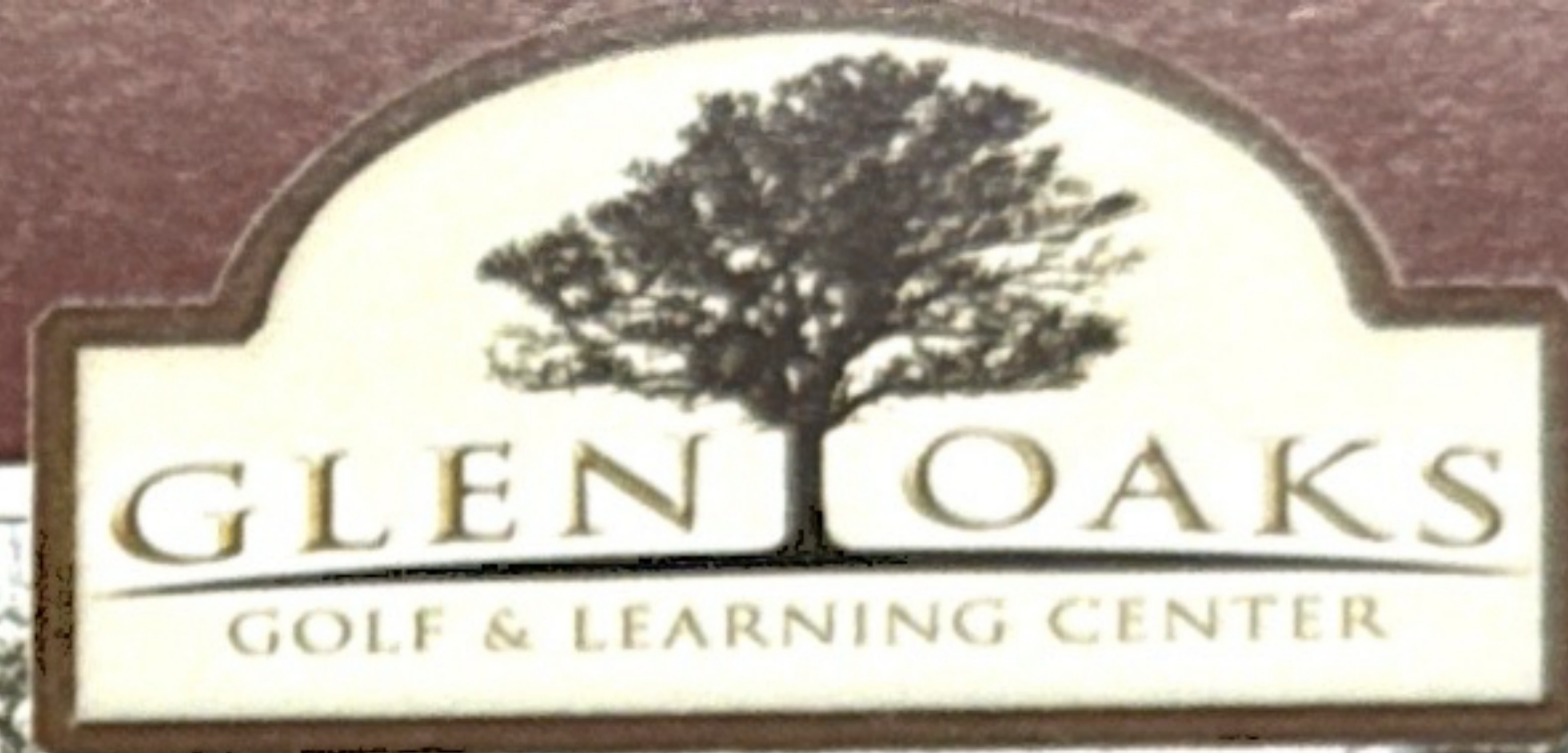
USGA Rules Govern All Play

EXCEPT WHERE MODIFIED BY LOCAL RULES

- Out of bounds defined by white stakes and course boundary fence. Penalty: stroke and distance.
- Be considerate of other players on the course. Avoid excessive noise and interference with their play.
- Repair all ball marks, rake bunkers, and fill divots. Leave the course in better condition than you found it.
- Each person on course must have three clubs, a putter and an approved bag or carrier. Caddies or spectators are not permitted on the course.
- Line-of-sight relief is permitted behind all screens that are installed for player protection.
- Most importantly: have fun and play well!
